CPI has an established Environmental Management System with the principal aim of improving environmental performance within the business.

Our sustainability strategy identifies commitments in four key focus areas: planet, customer and products, people and communities. Underpinning these four areas is our commitment to an ethical and responsible approach to how we conduct our business every day.

To continue improving environmental management, CPI is committed to the following:

- The prevention and reduction of pollution and the continual improvement of our environmental management system
- Reducing our use of natural resources, such as virgin aggregates, fossil fuels and water, using renewable sources for constituent materials from local businesses where practicable
- Working with our supply chain to ensure that we purchase materials from sustainable businesses wherever possible
- Producing an annual carbon footprint and implementing measures to reduce our carbon emissions. This will be achieved by reducing energy consumption and identifying opportunities to lower our carbon impact
- Continually reducing the environmental impacts associated with the transport of materials, goods and people
- Reduce the amount of waste sent to landfill by reusing waste wherever possible and increasing the recycling that takes place in our sites and through our waste contractors
- The development of new products to help our customers reduce their environmental impact. New products will under go life cycle assessment to reduce environmental harm throughout their life
- Improving the environmental awareness of our staff and contractors through training courses and awareness campaigns
- Recognising the impact we have on local communities and other interested parties and minimising any activities that may negatively affect them and consult with them where appropriate
